"[<u>NEW MATERIAL</u>] Each blanket or group health policy or certificate of insurance delivered, issued for delivery or renewed in New Mexico on or after July 1, 2001 that provides coverage for an insured's dependent shall not terminate coverage of an unmarried dependent by reason of the dependent's age before the dependent's twenty-sixth birthday."

Section 3. A new section of Chapter 59A, Article 46 NMSA 1978 is enacted to read:

"[<u>NEW MATERIAL</u>] Each individual and group health maintenance organization contract delivered or issued for delivery in New Mexico on or after July 1, 2001 that provides coverage for an enrollee's dependents shall not terminate coverage of an unmarried dependent by reason of the dependent's age before the dependent's twenty-sixth birthday."

Section 5. A new section of Chapter 59A, Article 47 NMSA 1978 is enacted to read:

"[<u>NEW MATERIAL</u>] Any individual or group subscriber contracts offered, issued or renewed in New Mexico on or after .135458.1 - 2 -
