AN ACT

**RELATING TO CONGRESSIONAL REDISTRICTING; ESTABLISHING
CONGRESSIONAL DISTRICTS FOR THE ELECTION OF REPRESENTATIVES TO
THE UNITED STATES CONGRESS; CHANGING A PROVISION OF THE
ELECTION CODE RELATING TO PRECINCTS; AMENDING, REPEALING AND
ENACTING SECTIONS OF THE NMSA 1978.**

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

**Section 1. Section 1-15-16 NMSA 1978 (being Laws 1991
(1st S.S.), Chapter 7, Section 1) is repealed and a new
Section 1-15-16 NMSA 1978 is enacted to read:**

**"1-15-16. [NEW MATERIAL] UNITED STATES REPRESENTATIVE--
COMPOSITION OF DISTRICTS. --**

17 A. Precinct designations and boundaries used in
18 the [~~1991~~] 2001 congressional redistricting are those precinct
19 designations and boundaries established pursuant to the
20 Precinct Boundary Adjustment Act and revised and approved
21 pursuant to that act by the secretary of state as of [~~August~~
22 ~~16, 1991~~] August 31, 2001.

23 B. [~~The boards~~] A board of county commissioners
24 shall not create any precinct that lies in more than one
25 congressional district [~~nor~~] and shall [~~the boards of county~~

1 ~~commissioners~~ not divide any precinct so that the divided
2 parts of the precinct are situated in two or more
3 congressional districts. Votes cast in [~~any general, primary~~
4 ~~or other~~] a statewide election from precincts created or
5 divided in violation of this subsection shall be invalid and
6 shall not be counted or canvassed. "
