

SENATE EDUCATION COMMITTEE SUBSTITUTE FOR
SENATE BILL 33

45TH LEGISLATURE - STATE OF NEW MEXICO - SECOND SESSION, 2002

AN ACT

RELATING TO EDUCATION; CREATING THE PUBLIC SCHOOL CODE REVIEW
TASK FORCE; REPEALING SECTIONS OF THE PUBLIC SCHOOL CODE AND
OTHER SECTIONS OF THE NMSA 1978; MAKING AN APPROPRIATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. TEMPORARY PROVISION--PUBLIC SCHOOL CODE
REVIEW TASK FORCE CREATED.--

A. The "Public School Code review task force" is
created, composed of sixteen members appointed as follows:

(1) one member of the house of
representatives, one principal and one teacher from New Mexico
public schools, appointed by the speaker of the house of
representatives;

(2) one member of the house of
representatives and one principal from a New Mexico public

1 school, appointed by the house of representatives minority
2 floor leader;

3 (3) one member of the senate, one principal
4 and one teacher from New Mexico public schools, appointed by
5 the president pro tempore of the senate;

6 (4) one member of the senate and one
7 principal from a New Mexico public school, appointed by the
8 senate minority floor leader;

9 (5) one member of the governor's staff
10 appointed by the governor;

11 (6) one member of the business community, who
12 is not employed in the education field or any education-
13 related services, appointed by the governor;

14 (7) one parent of a school-age child, who is
15 not employed in the education field or any education-related
16 services, appointed by the governor;

17 (8) two school district superintendents
18 appointed by the president of the state superintendents
19 association; and

20 (9) one member the state board of education
21 appointed by the president of the state board.

22 B. A vacancy on the task force shall be filled by
23 appointment and in the same manner as the vacant seat was
24 originally filled. All members of the task force shall be
25 appointed by July 31, 2002 and shall represent the geographic

1 and cultural diversity of the state.

2 C. The legislative education study committee, the
3 legislative council service and the state department of public
4 education shall coordinate the staffing of the task force.

5 D. The members of the task force may receive per
6 diem and mileage as provided in the Per Diem and Mileage Act,
7 but shall receive no other compensation, perquisite or
8 allowance.

9 E. The task force shall function from the date of
10 its appointment until December 31, 2003.

11 F. The task force shall initially hold an
12 organizational meeting to select a chairman and to develop a
13 work plan. Thereafter, the task force shall meet as necessary
14 to carry out its duties as provided in this section.

15 G. The task force shall conduct a review of the
16 Public School Code governing primary and secondary education
17 in New Mexico to identify those statutes that unnecessarily
18 burden administrators and teachers at the school site, and
19 that prevent administrators and teachers at the school site
20 from effectively performing their roles as instructional
21 leaders and educators.

22 H. In compliance with direction from the
23 legislative education study committee, the task force shall
24 present quarterly its findings and recommendations for an
25 efficient and effective Public School Code to the legislative

1 education study committee.

2 Section 2. APPROPRIATION.--Twenty thousand dollars
3 (\$20,000) is appropriated from the general fund to the state
4 department of public education for expenditure in fiscal years
5 2003 and 2004 to provide per diem and mileage for the members
6 of the Public School Code review task force. Any unexpended
7 or unencumbered balance remaining at the end of fiscal year
8 2004 shall revert to the general fund.
