designees residing within school district boundaries,
verifying that the tribes agree to Indian policies and
procedures pursuant to federal requirements; and

H. seek funds to establish, develop and implement the following support services for the purposes of increasing the number of American Indian teachers and principals and providing continued professional development for teachers and principals serving American Indian students, in conjunction with an established policy advisory group to the state board and the commission on higher education:

(1) recruitment;

(2) academic transition programs;

(3) academic financial support;

(4) teacher preparation;

1 (6) professional development; and 2 Ι. ensure that native language bilingual programs are part of a school district's professional development plan, 3 as provided in Section 22-2-2 NMSA 1978." 4 A new section of the Public School Code is Section 8. 5 6 enacted to read: 7 "[NEW MATERIAL] ADVISORY COUNCIL. --A. The advisory council established by the Indian 8 9 education division shall consist of not more than ten American 10 Indian educators and others needed to assist in evaluating, 11 consolidating and coordinating all activities relating to 12 education of American Indian students. Representation shall 13 consist of: 14 (1) two members representing the pueblos; (2)two members representing Navajo agencies; 15 16 two members representing Apache tribes; (3) 17 (4) two public school educators; and 18 two nonpublic school educators. (5) 19 **B**. On a semiannual basis, representatives from all 20 tribes, members of the state board, the governor's office, the 21 New Mexico office of Indian affairs, the legislature, the 22 state superintendent and the advisory council shall meet to 23 assist in evaluating, consolidating and coordinating all 24 activities relating to the education of American Indian 25 students. . 139953. 1

C. Members of the council shall receive per diem and mileage as provided for nonsalaried public officers in the Per Diem and Mileage Act."

Section 9. A new section of the Public School Code is enacted to read:

"[<u>NEW MATERIAL</u>] REPORT. - -

A. The Indian education division in cooperation with the education division of the bureau of Indian affairs and other entities that serve American Indian students, shall submit a statewide American Indian education status report on an annual basis to all tribes.

B. A school district with tribal lands located
within its boundaries shall provide a district-wide American
Indian education status report on an annual basis to all
tribes represented within the school district boundaries.

C. The status reports set forth in Subsections A and B of this section shall be written in a brief format and shall include the following information, through which public school performance shall be measured and reported to the tribes:

(1) student achievement as measured by a statewide test approved by the state board;

(2) school safety;

(3) the dropout rate;

18	fund shall be administered by the department of education, and
19	money in the fund, including interest, is appropriated to the
20	department to distribute awards for the purpose of supporting
21	the Indian Education Act. The department of education shall
22	develop procedures and rules for the award of money from the
23	fund. Disbursement of the fund shall be made by warrant of
24	the department of finance and administration pursuant to

or unencumbered balance remaining in the fund at the end of a fiscal year shall not revert but shall remain to the credit of the fund."

Section 11. APPROPRIATION. -- Two million four hundred twenty-six thousand dollars (\$2,426,000) is appropriated from the general fund to the Indian and higher education fund for expenditure in fiscal year 2003 to carry out the purposes of the Indian Education Act. Any unexpended or unencumbered balance remaining at the end of fiscal year 2003 shall not revert but shall remain to the credit of the fund.

Section 12. REPEAL. -- Sections 22-2-11 through 22-2-13 NMSA 1978 (being Laws 1975 (1st S.S.), Chapter 8, Sections 1 through 3) are repealed.
