5	Section 1. SHORT TITLEThis act may be cited as the "Youth Council Act".
6	Section 2. PURPOSEThe purpose of the Youth Council Act is to encourage
7	young people throughout New Mexico to consider and discuss the problems they face
8	and to develop possible solutions for presentation to the governor, lieutenant
9	governor and legislature.
10	Section 3. YOUTH COUNCIL CREATEDORGANIZATIONFUNCTIONS
11	DEFINITION
12	A. The "youth council" is created in the children, youth and families
	department.
13	B. The council shall consist of at least one youth, aged fourteen to
14	nineteen, from each New Mexico legislative district to be selected by county child
15	welfare advocates and officials, educational advisors, faith-based organizations and
16	community-based youth-serving organizations, in consultation with the legislators from
17	whose district the youth is being selected.
18	C. The council shall meet at least four times a year for the purpose of
19	discussing the problems faced by New Mexico youth and to recommend possible
	solutions to these problems to be presented to the governor, lieutenant governor and
20	legislature. Meetings shall not be scheduled to interfere with council participants'
21	school attendance.
22	D. The council shall issue an annual report that summarizes the
23	activities and findings of the council. The report shall be submitted to the legislature
24	and the executive no later than November 15 of each year. E. As used in the Youth Council Act, "council" means the youth
25	council.

2	CREATEDDUTIES
3	A. The position of "youth council coordinator" is created in the office of
4	the secretary of children, youth and families to organize, administer and coordinate
5	youth council activities.
	B. The coordinator shall:
6	(1) select, in consultation with the appropriate legislators,
7	county child welfare advocates and officials, educational advisors, faith-based
8	organizations and community-based youth-serving organizations, a diverse cross
9	section of youths for the council from throughout the state;
10	(2) organize four council meetings a year, four of which will
11	include the lieutenant governor and two of which will include the governor;
12	(3) ensure that there is adequate adult supervision for youths
	participating in council activities;
13	(4) assist the council in preparing an annual report on its
14	activities and findings; and
15	(5) act as a liaison between the council and
16	any interagency coordinating group consisting of certain
17	cabinet secretaries if that entity is established by
18	executive order.
