5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
6	Section 1. Section 21-1-27.1 NMSA 1978 (being Laws 2002, Chapter 31,
7	Section 1) is amended to read:
8	"21-1-27.1. FACULTY ENDOWMENT FUND CREATED
9	A. The "faculty endowment fund" is created in the state treasury. The
10	fund shall consist of appropriations, income from investment of the fund, gifts, grants,
11	donations and bequests. Money in the fund shall not revert at the end of any fiscal
12	year.
	B. The faculty endowment fund shall be administered by the
13	commission on higher education. Except as provided in Subsection J of this section,
14	money shall be disbursed only on warrant of the secretary of finance and
15	administration upon voucher signed by the executive director of the commission on
16	higher education or his authorized representative.
17	C. Money shall be disbursed from the faculty endowment fund only to
18	establish endowments for chairs, professorships and faculty development programs at
19	four-year public post-secondary educational institutions as provided in this section.
	Except as provided in Subsection J of this section, an institution shall not receive a
20	disbursement for an endowment until that institution has notified the commission on
21	higher education that it has received matching funds for the endowment from other
22	than governmental sources in an amount that is equal to or greater than the amount
23	authorized by this section to be disbursed for the endowment.
24	D. Except as provided in Subsection J of this section, money in the
25	faculty endowment fund is appropriated to the commission on higher education to be
	disbursed for the following endowment purposes in the following amounts:

1	(1) for endowed chairs, five number thousand dollars
2	(\$500,000) for each endowed chair;
3	(2) for endowed professorships, two hundred thousand dollars
4	(\$200,000) for each endowed professorship; and
	(3) for endowed faculty development programs, to include
5	lectureships, graduate fellowships and other faculty support programs, thirty-seven
6	thousand five hundred dollars (\$37,500) for each endowed faculty development
7	program.
8	E. Except as provided in Subsection J of this section, until June 30,
9	2005, the following institutions shall be eligible for the following disbursements from the
10	fund:
11	(1) the university of New Mexico for four endowed chairs;
	(2) New Mexico state university for four endowed chairs;
12	(3) New Mexico institute of mining and technology for two
13	endowed chairs;
14	(4) the university of New Mexico for two endowed chairs at the
15	university of New Mexico medical center; and
16	(5) the university of New Mexico, New Mexico state university,
17	New Mexico highlands university, New Mexico institute of mining and technology,
18	western New Mexico university and eastern New Mexico university for endowed
	professorships and endowed faculty development programs. The number of endowed
19	professorships and endowed faculty development programs allocated to each of the
20	named institutions shall be in the same ratio to the total number of endowed
21	professorships and endowed faculty development programs allocated to all of the
22	named institutions as the main campus full-time-equivalent enrollment of the institution
23	bears to the total main campus full-time-equivalent enrollment of all of the named
24	institutions. For purposes of this paragraph, the main campus full-time-equivalent
25	enrollment of each institution shall be based on enrollment figures for the second
45	semester of the 2001-2002 school year.

4	matching funds. Disbursements may be made based on the date requests for
	additional disbursement are received by the commission.
5	G. The endowment funds of the institutions shall not be expended but
6	shall be invested by the institutions in accordance with the prudent man rule, and in
7	accordance with the provisions of Section 21-1-38 NMSA 1978. The income from the
8	investments shall be used by the institutions to provide funding for chairs,
9	professorships and faculty development programs, including paying all or a portion of
10	the salary of the faculty member or the expenses necessary to support associated
11	academic activities.
	H. Except as provided in Subsection J of this section, disbursements of
12	the faculty endowment fund by the commission on higher education shall be allocated
13	as follows:
14	(1) fifty percent of the disbursements shall be for endowed
15	chairs;
16	(2) thirty-five percent of the disbursements shall be for
17	endowed professorships; and
18	(3) fifteen percent of the disbursements shall be for endowed
	faculty development programs.
19	I. If the disbursements allocated for endowed chairs are not sufficient
20	to fund the number of positions specified in Paragraphs (1) through (4) of Subsection
21	E of this section, the number of endowed chairs for each of those four institutions shall

be proportioned by the commission on higher education in the same manner as

proportioned in Paragraph (5) of Subsection E of this section, except that each of the

endowed professorships and endowed faculty development programs are

four institutions shall be allocated at least one endowed chair.

J. Up to three million dollars (\$3,000,000) of the faculty endowment

fund may be disbursed after July 1, 2003 to the commission on higher education to
endow and disburse the money for one endowed chair each to the university of New
Mexico, New Mexico state university and the New Mexico institute of mining and
technology. Each endowed chair shall be eligible for one million dollars (\$1,000,000)
upon notification by the institution that it has received matching funds for the
endowment from other than state sources in an amount equal to or greater than five
hundred thousand dollars (\$500,000) for establishment of an endowed chair that is
directly related to the economic development of the state."
