AN ACT
RELATI NG TO MDTOR VEHI CLES; PROHI BI TI NG THE USE OF A HAND HELD CELLULAR PHONE WHI LE DRI VI NG A MDTOR VEHI CLE; PROVI DI NG A PENALTY.

BE IT ENACTED BY THE LEG SLATURE OF THE STATE OF NEW MEXI CO:
Section 1. A new section of the Mbt or Vehi cle Code, Section 66-7-358. 1 NMSA 1978, is enacted to read:
" 66-7-358. 1. [ NEW MATERI AL] HAND- HELD CELLULAR PHONE USE PROH BI TI ON. --A person shall not use a hand-hel d cellul ar phone while driving a motor vehicle on a hi ghway."

Section 2. Section 66-8-116 NMSA 1978 (bei ng Laws 1978, Chapter 35, Section 524, as amended) is amended to read:
"66-8-116. PENALTY ASSESSMENT M SDEMEANORS- -
