**B**. A person shall not represent himself to be a member of the civil air patrol, New Mexico wing if that person 3 4 is, in fact, not a member of the civil air patrol, New Mexico The secretary shall determine what constitutes wi ng. satisfactory proof that a person is a member of the civil air 6 7 patrol, New Mexico wing.

A person who violates the provisions of C. Subsection B of this section is guilty of a petty misdemeanor and shall be sentenced pursuant to Section 31-19-1 NMSA 1978.

D. A fee of twenty-five dollars (\$25.00), which shall be in addition to the regular motor vehicle registration fee, shall be collected by the department for the original issuance of the special registration plate for a member of the civil air patrol, New Mexico wing.

Ten dollars (\$10.00) of the fee collected Е. pursuant to Subsection D of this section shall be retained by the department and is appropriated to the department to defray the cost of making and issuing special registration plates for members of the civil air patrol, New Mexico wing. The remaining fifteen dollars (\$15.00) shall be deposited in the motor vehicle suspense fund for distribution in accordance with Section 66-6-23 NMSA 1978.
