Section 2. Section 28-1-7 NMSA 1978 (being Laws 1969, Chapter 196, Section 7, as amended) is amended to read:

UNLAWFUL DISCRIMINATORY PRACTICE. -- It is an "28-1-7. unlawful discriminatory practice for:

A. an employer, unless based on a bona fide 7 occupational qualification or other statutory prohibition, to refuse to hire, to discharge, to promote or demote or to 8 9 discriminate in matters of compensation, terms, conditions or privileges of employment against any person otherwise qualified because of race, age, religion, color, national origin, ancestry, sex, sexual orientation, gender identity, physical or mental handicap or serious medical condition, or, if the 13 employer has fifty or more employees, spousal affiliation; provided, however, that 29 U.S.C. Section 631(c)(1) and (2) shall apply to discrimination based on age; 16

a labor organization to exclude [an individual] **B**. <u>a person</u> or to expel or otherwise discriminate against any of its members or against any employer or employee because of race, religion, color, national origin, ancestry, sex, sexual orientation, gender identity, spousal affiliation, physical or mental handicap or serious medical condition;

Section 3. A new section of the Human Rights Act is enacted to read:

"[<u>NEW MATERIAL</u>] QUOTAS PROHIBITED.--A person, employer, employment agency or organization shall not use the provisions of the Human Rights Act to adopt or implement a quota on the basis of sexual orientation or gender identity."

Section 4. Section 28-1-9 NMSA 1978 (being Laws 1969, Chapter 196, Section 8, as amended) is amended to read:

apply to any single-family dwelling sold, leased, 3 A. 4 subleased or rented by an owner without the making of any notice, statement or advertisement with respect to the sale, 5 lease, sublease or rental of a dwelling unit that indicates any 6 7 preference, limitation or discrimination based on race, color, religion, national origin, ancestry, [or] sex, sexual 8 9 orientation or gender identity. This exemption is subject to 10 these further reservations:

(1) to qualify for the exemption, the seller
 must not be an owner of or own or have reserved any interest in
 more than three single-family dwellings; and

(2) if the seller [doesn't presently] does not currently live in the dwelling or he was not the most recent occupant, [then] the exemption granted in this section [will] shall only apply to one sale in twenty-four months;

B. bar any religious or denominational institution or organization [which] that is operated, [or] supervised or controlled by or that is operated in connection with a religious or denominational organization from limiting admission to or giving preference to persons of the same religion or denomination or from making selections of buyers, lessees or tenants as are calculated by the organization or denomination to promote the religious or denominational principles for which it . 143099.1
