## SENATE BI LL 211, as amended

has had it under consideration and reports same with recommendation that it DO PASS, amended as follows:

1. On page 1, I ine 11, after the semi col on insert "ENACTI NG A DESCRI PTI ON OF AND REQUI REMENTS FOR A STANDARD ZED SPECI AL REGI STRATI ON PLATE; " and after "FOR" insert "STANDARDI ZED".
2. On page 1, line 12, after "PLATES" insert "WTH LOGOS".
3. On page 1 , between Iines 15 and 16 , insert the following new section to read:
"Section 1. A new section of the Mbtor Vehicle Code, Section 66-3-424 NMSA 1978, is enact ed to read:
"66-3-424. [ NEW MATERI AL] STANDARDI ZED SPECI AL REG STRATI ON PLATES W TH LOGOS. --
A. Standardized special registration plates with Iogos may be authorized by stat ute to show state support for worthy public purposes. The authorizing statute shall provide for collection of fees that, at a minimumill cover the costs to the division of devel opment, manufacture and issuance of the special registration pl at es and Iogos.
B. Standardized special regi stration plates, on the standar di zed areas, shal I:
(1) di splay the col ors of the state flag, red lettering on a yellow background;
（2）di spl ay the phrases＂New Mexi co USA＂and＂Land of Enchant ment＂；
（3）provi de a space for appl yi ng the speci al regi stration logo，centered at the left edge of the plate，bet ween the attachment hol es，begi nni ng one－fourth inch in from the edge of the pl ate and having the following di mensi ons：four and one－ei ghth i nches in hei ght and three and one－ei ghth inches in width；and
（4）provi de a vehi cle regi stration number，to be assi gned by the di vision，that consists of five al phanumeric characters di spl ayed to the right of the special logo area．

C．Special regi stration logos，except for the standard di mensi on speci fied in Paragraph（3）of Subsection B of this section，shall be left to the design di scretion of the di vi sion，in consultation with the public purpose interest group that requests the special regi stration plat

D．Standardized special registration plates with Iogos， when authorized by statute for a particular public purpose interest group，shall meet the requi rements specified in this subsection prior to pl ate issuance by the di vision．The publ ic purpose interest group，no later than the effective date of the authorizing st at ute：
（1）shal l provi de evi dence acceptable to the di vi si on that it will generate a mi nimm number of prepaid applications as determined by the di vi si on for the special regi stration pl ate with Iogo；
（2）shall provi de a prepayment to the di vi si on in an amount sufficient to cover the plate and logo cost of the initial or der；
（3）shall provi de a sampl e of the requested artwork desi gn in a format specified by the plate manuf acturer for the speci alized logo；and
（4）in cases where the authorizing statute incl udes revenue sharing with di stribution directed to a particular group or fund，shal $l$ show that the reci pi ent is a governmental entity or a fund authorized for the use of a governmental entity．

E．The di vi si on n⿴囗十 proml gate rules for implement ation of the provisions of this section．＂＂．

7. On page 1, line 20, after "issue" insert "a standardized" and on line 21 strike "pl ates to any person who" and insert in lieu thereof "plate with a logo specified in Section 66-3-424 NMSA 1978 i ndi cating that the reci pi ent".
8. On page 2, line 11, strike "ten dollars (\$10.00)" and insert in lieu ther eof "twenty-five dollars (\$25.00)".
9. On page 2, Ii ne 14, strike "The" and insert in Iieu ther eof "Ten dollars (\$10.00) of the" and after "fee" insert "collected".
10. On page 2, Iine 17, after the period insert:
"The remai ning fifteen dollars (\$15.00) shall be deposited in the mot or vehicle suspense fund for distribution pursuant to Section 66-6-23 NMSA 1978. ".
11. On page 2, I ines 18 and 19, strike "pl ate desi gn" and insert in lieu ther eof "I ogo desi gns" and on line 19, after the second occurrence of "for" insert "active or retired".
12. On page 2, line 20, strike "pl ate" and insert in lieu thereof "I ogos" and after "as" insert ""active letter carrier"".
13. On page 2, line 21, before "mail" insert "retired".
14. On page 3, line 2, after "plate" insert "with Iogo for an active letter carrier".
15. On page 3, line 3, strike "retain" and insert in lieu thereof "exchange" and after "pl ate" insert "for a special plate with logo for a retired letter carrier".
16. On page 3, bet ween Iines 3 and 4, insert the following new section to read:
"Section 3. EFFECTI VE DATE. - Except for Section 1 of this act, the effective date of the provisions of this act is January 1 ,
