A release recorded pursuant to this section 15 shall be deemed to be the equivalent of a release recorded 16 pursuant to Section 48-7-4 NMSA 1978. 17 In addition to any other remedy, a title insurer D. 18 recording a release pursuant to this section shall be liable to 19 any mortgagee or beneficiary of a deed of trust for damages, 20 including attorney fees, that the mortgagee or beneficiary of a 21 deed of trust may sustain by reason of the wrongful recording 22 of a release of mortgage or deed of trust. 23 Ε.
