SUMMARY

Synopsis of SEC Amendments

The amendments adopted by the Senate Education Committee insert the designation for subsection "A", and add language requiring an evaluation of the program: as recommended by the CHE:

"A plan for a program evaluation, including specific program goals and criteria for assessing program effectiveness, shall be submitted to the Legislative Finance Committee and the Commission on Higher Education by October 1, 2004. An assessment of the program will be completed prior to June 30, 2005, and submitted to the Legislative Finance Committee and the Commission on Higher Education

Synopsis of Original Bill

Senate Bill 415 appropriates \$300.0 from the general fund to the Board of Regents of New Mexico State University (NMSU) to create a center for border superintendency to improve education

in the United States-Mexico border region through the preparation and professional development of current and aspiring New Mexico superintendents.

Significant Issues

This request was not included in New Mexico State University's budget request to the NMSU Board of Regents, and thus was not included in the list of priority projects submitted by NMSU to the CHE for review.

FISCAL IMPLICATIONS

The appropriation of \$300.0 contained in this bill is a recurring expense to the general fund. Any unexpended or unencumbered balance remaining at the end of fiscal year 2004 shall revert to the general fund. The NMSU analysis states this is a one-time request and will enable NMSU to seek funding from other sources.

NMSU reports that the appropriated funds will be administered as in the following budget:

OTHER SUBSTANTIVE ISSUES

This bill addresses the need to prepare and continue to provide professional development activities for current and aspiring superintendents to serve schools in the United States-Mexico border region and more effectively meet the unique needs of students in the area. According to the NMSU analysis, this would be accomplished by developing a distance education doctoral program in education administration, establishing a Center to conduct research on problems in the area, providing support for doctoral students in the area of distance education and serving as a resource to schools in the NMSU service region.

An assessment of the program will be completed prior to June 30, 2005, and submitted to the Legislative Finance Committee and the Commission on Higher Education."

- 2. Could a consortium of the districts involved provide some seed money for the project?
- 3. Doesn't NMSU offer distance education programs already?
