11	PROPOSING TO AMEND ARTICLE 12, SECTION 6 OF THE CONSTITUTION OF
12	NEW MEXICO TO MOVE FINANCIAL FUNCTIONS FROM THE STATE BOARD OF
13	EDUCATION AND THE STATE DEPARTMENT OF PUBLIC EDUCATION TO THE
14	DEPARTMENT OF FINANCE AND ADMINISTRATION.

16	BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
17	Section 1. It is proposed to amend Article 12, Section 6
18	of the constitution of New Mexico to read:
19	"A. There is hereby created a "state department of
20	public education" and a "state board of education". The state
21	board of education shall determine public school policy and
22	vocational educational policy and shall have control,
23	management and direction [including financial direction,
24	distribution of school funds and financial accounting for all
25	public schools] pursuant to authority and powers provided by

law. The board shall appoint a qualified, experienced educational administrator to be known as the superintendent of public instruction, who shall, subject to the policies established by the board, direct the operation of the state department of public education.

B. Ten members of the state board of education who shall be state officers shall be elected for staggered terms of four years as provided by law. Board members shall be residents of the board of education district from which they are elected. Change of residence of a board member to a place outside the district from which he was elected shall automatically terminate the term of that member.

C. Five members of the state board of education who shall be state officers shall be nominated and by and with the consent of the senate appointed by the governor from five districts substantially equal in population for staggered four-year terms as provided by law. Those appointed by the governor shall be qualified electors of the state of New Mexico, no more than one-half or a simple majority of whom at the time of their appointment shall be members of the same political party. After 1990, the number of appointed members may be changed by law not to exceed five members.

D. The governor shall fill vacancies on the board by appointment of a resident from the district in which the vacancy occurs until the next regular election for membership . 144661.1

3	relating to the distribution of school funds and financial
