11	PROPOSING AN AMENDMENT TO ARTICLE 12, SECTION 6 OF THE
12	CONSTITUTION OF NEW MEXICO TO TRANSFER THE STATE DEPARTMENT OF
13	PUBLIC EDUCATION TO A CABINET DEPARTMENT HEADED BY A SECRETARY
14	OF PUBLIC EDUCATION WHO SHALL SERVE IN THE EXECUTIVE CABINET
15	AND TO CREATE AN ALL-ELECTED STATE BOARD OF EDUCATION.

17	BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
18	Section 1. It is proposed to amend Article 12, Section 6
19	of the constitution of New Mexico to read:
20	"A. There is hereby created a "[state department
21	of] public education <u>department</u> " and a "state board of
22	education". The [state board of education shall determine
23	public school policy and vocational educational policy and
24	shall have control, management and direction, including

2	powers provided by law. The board shall appoint a qualified,
3	experienced educational administrator to be known as the
4	superintendent of public instruction, who shall, subject to the
5	policies established by the board, direct] department shall be
6	a cabinet department headed by a secretary of public education
7	who is a qualified, experienced educator who shall be appointed
8	by the governor and confirmed by the senate. The secretary of
9	public education, with the advice of the state board of
10	education, shall determine public school policy and vocational
11	educational policy. The secretary, after consulting with the
12	state board of education, shall have control, management and
13	<u>direction, including financial direction, distribution of</u>
14	school funds and financial accounting for all public schools,
15	pursuant to authority and powers provided by law. The
16	operation of the [state department of] public education
17	<u>department shall be as provided by law</u> .

B. Ten members of the state board of education who shall be state officers shall be elected for staggered terms of four years as provided by law. Board members shall be residents of the board of education district from which they are elected. Change of residence of a board member to a place outside the district from which he was elected shall automatically terminate the term of that member.

who shall be state officers shall be nominated and by and with the consent of the senate appointed by the governor from five districts substantially equal in population for staggered four-year terms as provided by law. Those appointed by the governor shall be qualified electors of the state of New Mexico, no more than one-half or a simple majority of whom at the time of their appointment shall be members of the same political party. After 1990, the number of appointed members may be changed by law not to exceed five members.

D.-] C. The governor shall fill vacancies on the board by appointment of a resident from the district in which the vacancy occurs until the next regular election for membership on the board.

[E. Upon adoption of this amendment] D. All functions relating to the distribution of school funds and financial accounting for the public schools shall be transferred to the [state department of] public education <u>department</u> to be performed as provided by law.

E. The members of the 2002 state board of education shall constitute the state board of education if this amendment is approved until their terms expire."

Section 2. The amendment proposed by this resolution shall be submitted to the people for their approval or rejection at the next general election or at any special election prior to that date that may be called for that .143554.1
