14	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
15	Section 1. Section 31-21-24 NMSA 1978 (being Laws 1975,
16	Chapter 194, Section 3, as amended) is amended to read:

19	A. [There is created] The "parole board" <u>is</u>
20	created, consisting of [nine] fifteen members appointed by the
21	governor with the consent of the senate.
22	B. The terms of the members of the parole board
23	shall be six years. To provide for staggered terms, [three of
24	the initially appointed members, including the chairman, shall
25	be appointed for terms of six years, three members for terms of

Thereafter, all members shall be appointed for six-year terms] five members shall be appointed every two years. Members serve until their successors have been appointed and qualified.

5 C. Members of the parole board may be removed by 6 the governor as provided in Article 5, Section 5 of the 7 constitution of New Mexico. Vacancies shall be filled by 8 appointment by the governor for the remainder of the unexpired 9 term.

D. Members of the parole board shall be persons qualified by such academic training or professional experience as is deemed necessary to render them fit to serve as members of the board. No member of the board shall be an official or employee of any other federal, state or local government entity.

E. Members of the parole board shall receive per diem and mileage as provided for nonsalaried public officers in the Per Diem and Mileage Act and shall receive no other compensation, perquisite or allowance.

F. The governor shall designate one member of the parole board to serve as [chairman] chair, who in addition to other duties shall coordinate with the corrections department in the furnishing of services pursuant to Section 9-3-11 NMSA 1978.

G. A parole may be granted, denied or revoked by a .154200.1
