"When a module becomes effective as provided in Subsection F of Section 21-1B-6 NMSA 1978, if a student's articulation complaint regarding courses contained in a module is upheld,".

- 16. On page 8, lines 15 and 16, strike both occurrences of "taken" and insert in lieu thereof "earned".
- 17. On page 9, line 2, after "to" strike the remainder of the line up to the period and insert in lieu thereof "those complaints".,
