15	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
16	Section 1. Section 30-36-10 NMSA 1978 (being Laws 1984,
17	Chapter 110, Section 4) is amended to read:
18	"30-36-10. DISTRICT ATTORNEYPROCESSING FEE
19	A. A district attorney is authorized to assess a
20	processing fee against $[any]$ <u>a</u> person who is convicted of
21	violating Section 30-36-4 NMSA 1978 and against [any] <u>a</u> person
22	who acknowledges violation of that section but for whom
23	prosecution is waived by the district attorney. The processing
24	fee assessed pursuant to this section shall not exceed:
25	[(1) five dollars (\$5.00) if the amount of the
