4 (1)assist districts in the development of 5 district soil and water conservation programs and, from such 6 programs, develop a soil and water conservation program for the 7 state;

8 provide information for supervisors (2) 9 concerning the experience and activities of all districts and 10 facilitate the exchange of experience and advice among 11 districts;

promote cooperation between districts and, (3) by advice and consultation, assist in the coordination of 14 district programs;

(4) secure and maintain the cooperation and assistance of state and federal agencies and seek to secure and maintain the cooperation and assistance of national, state and local organizations and groups interested or active in natural resources conservation and development;

disseminate information throughout the (5) state concerning district activities and programs; and

encourage and, within budget limitations, (6) render assistance to district activities and facilitate and encourage the formation of new districts in areas where district organization is desirable.
