Except as authorized in Subsection C of this section, the tuition scholarships authorized in this section 4 5 shall apply only to full-time resident students who, immediately upon completion of a high school curriculum at a 6 7 public or accredited private New Mexico high school or upon 8 receiving a graduate equivalent diploma, are accepted for 9 entrance to and attend one of the state educational 10 institutions set forth in this section or one of the branches 11 of those institutions. Each tuition scholarship shall be 12 awarded for up to four consecutive years beginning the second 13 semester of the recipient's first year of enrollment, provided 14 that the recipient has maintained residency in New Mexico and 15 maintained a grade point average of 2.5 or higher on a 4.0 16 scale during [his] the first semester of full-time enrollment.

C. The tuition scholarships authorized in this section shall also apply to full-time resident students who, immediately upon completion of a high school curriculum at a public or accredited private New Mexico high school or upon receiving a graduate equivalent diploma, attend a two-year public post-secondary educational institution in New Mexico and who, upon the completion of that curriculum or at the end of two years, whichever is sooner, transfer to one of the postsecondary state educational institutions set forth in this .153630.1

section. Those students shall be eligible for a tuition scholarship for two consecutive years, provided that those students maintain residency in New Mexico, maintain a grade point average of 2.5 or higher on a 4.0 scale and attend the institution full time during the regular academic year.

The tuition scholarships authorized in this D. section shall also apply to full-time resident students who:

8 (1) within one hundred twenty days of 9 completion of a high school curriculum at a public or 10 accredited private New Mexico high school, or of receiving a graduate equivalent diploma, begin service in the United States 12 armed forces: and

(2)within one hundred twenty days of completion of honorable service or medical discharge from the service are accepted for entrance to and attend one of the state educational institutions set forth in this section.

E. Students at one of the four-year institutions listed in Subsection A of this section are ineligible for tuition scholarships for the semesters they are enrolled in one or more remedial courses. Students at northern New Mexico state school are ineligible for tuition scholarships for the semesters in which they are enrolled in two or more remedial courses.

Section 2. Section 21-13-10 NMSA 1978 (being Laws 1963, Chapter 17, Section 9, as amended) is amended to read:

"21-13-10. BOARD DUTIES. - -

A. It is the duty of the community college board to determine financial and educational policies of the community college. The community college board shall provide for the management of the community college and execution of these policies by selecting a competent president for the community college, and, upon the president's recommendation, the board shall employ other administrative personnel, instructional staff or other personnel as may be needed for the operation, maintenance and administration of the community college.

B. The community college board shall have the power to fix tuition and fee rates for resident and nonresident students of the <u>community college</u> district, to accept gifts, to accept federal aid, to purchase, hold, sell and rent property and equipment and to promote the general welfare of the institution for the best interest of educational service to the people of the community college district.

Guidelines shall be distributed to community college boards to enable a uniform availability of the resident student tuition scholarships."

"21-16-10.1. TUITION SCHOLARSHIPS AUTHORIZED. --

A. To the extent that funds are made available by the legislature from the lottery tuition fund, the board of a technical and vocational institute shall award tuition scholarships for qualified resident students attending a technical and vocational institute.

B. The tuition scholarships authorized in this section shall apply only to full-time resident students who, immediately upon completion of a high school curriculum at a public or accredited private New Mexico high school or upon receiving a graduate equivalent diploma, are accepted for entrance to and attend a technical and vocational institute. Each tuition scholarship shall be awarded for up to two consecutive years beginning the second semester of the recipient's first year of enrollment, provided that the recipient has maintained residency in New Mexico and maintained a grade point average of 2.5 or higher on a 4.0 scale during [his] the first semester of full-time enrollment with renewal of an additional two years upon transfer.

<u>C. Students are ineligible for tuition scholarships</u> for the semesters in which they are enrolled in two or more remedial courses.
