BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 59A-53-5.1 NMSA 1978 (being Laws 1998, Chapter 76, Section 3) is amended to read:

"59A-53-5. 1. [MAXIMUM AMOUNTS TO BE CERTIFIED] BASE
DISTRIBUTION--ADDITIONAL AMOUNTS. --

A. For fiscal year 2000 and each fiscal year thereafter, the marshal shall certify a total <u>base</u> amount pursuant to Sections 59A-53-4 and 59A-53-5 NMSA 1978 not to exceed the greater of the total distribution pursuant to those sections for the previous fiscal year or an amount to be
