CAPITAL IMPROVEMENTS IN CHAVES COUNTY

This capital outlay request is revised to read as follows:

• to the fifth judicial district court

5TH JUD DIST VIDEO ARRAIGNMENT EQUIP

thirty thousand dollars (\$30,000) to plan, design, purchase and install video arraignment equipment for the fifth judicial district court in Chaves county

CHAVES CO COURTHOUSE FURNITURE

one hundred thousand dollars (\$100,000) to purchase furniture for the county courthouse in Chaves county

• to the department of transportation

EAST BRASHER RD PAVEMENT PRJT

one hundred eighty thousand dollars (\$180,000) to make improvements related to the pavement preservation project on east Brasher road in Chaves county

WEST MCGAFFEY STREET PAVEMENT PRJT-PH 2

one hundred seventy-five thousand dollars (\$175,000) for phase 2 improvements related to the pavement preservation project on west McGaffey street between the Roswell relief route and Sycamore avenue in Chaves county

one hundred thousand dollars (\$100,000) to purchase ignition interlock devices for Chaves county

CHAVES CO MUSEUM BOOKCASES

twenty-five thousand dollars (\$25,000) to plan, design and construct or purchase and install bookcases at the courthouse museum in Chaves county

EAST GRAND PLAINS VOLUNTEER FIRE DEPT TRUCK

five hundred fifty thousand dollars (\$550,000) to purchase an aerial ladder truck for the east Grand Plains volunteer fire department in Chaves county
