CIBOLA CO ROAD 34 IMPROVE

three hundred seventy-five thousand dollars (\$375,000) to plan, design and construct improvements, including drainage structures and surfacing, to county road 34 in Cibola county

CIBOLA CO ROAD 41 IMPROVE

three hundred thousand dollars (\$300,000) to plan, design and construct improvements, including drainage structures, cattle guards and surfacing, to county road 41 in Cibola county

CIBOLA CO ROAD 42 IMPROVE

three hundred thousand dollars (\$300,000) to plan, design and construct improvements, including drainage structures, cattle guards and surfacing, to county road 42 in Cibola county

CIBOLA CO ROAD 49 IMPROVE

two hundred sixty thousand dollars (\$260,000) to plan, design and construct improvements, including drainage structures and surfacing, to county road 49 in Cibola county
