#### **SUMMARY**

Synopsis of Bill

House Bill 942 appropriates \$2,514,600.0 from the general fund to the board of regents of New Mexico Highlands University to pay the principal balance on outstanding loans.

#### FISCAL IMPLICATIONS

The appropriation of \$2,514,600.0 contained in this bill is a non-recurring expense to the general fund. Any unexpended or unencumbered balance remaining at the end of FY06 would revert to the general fund.

### **OTHER SUBSTANTIVE ISSUES**

The Legislative Finance Committee prepared a *Review of Financial and Administrative Processes*, *New Mexico Highlands University* in October 2004 at the request of the Board of Regents. The report recommends the institution "pay down the bank loan that may violate the New Mexico Constitution as soon as feasible and refrain from drawing on lines of credit in the future" (pages 2-3).
