SUMMARY

Synopsis of Bill

House Bill 983 requires non-United States citizens to be classified on the same basis as citizens

House Bill 983 -- Page 2

when determining tuition rates at state educational institutions included in Article 12, Section 11 of the New Mexico Constitution. Non-United States citizen is defined as a person and the person's children who are not citizens.

Significant Issues

The bill is targeted to those individuals who are lawfully in the United States. This bill appears to target a different group of students than Senate Bill 582.

In November 2004, the CHE revised its residency regulation (5.7.18 NMAC). One of the changes approved was to delete the former section 5.7.18.9 D. which defined "Non-U.S. Citizen". The language that was deleted from the regulation read as follows: ""Non-U.S. citizen" means persons and their children who are not citizens of the United States shall be classified as residents or non-residents on the same basis as citizens of the United States if they are lawfully in the United States and have obtained permanent resident status from the Immigration and Naturalization Service (INS). Non-citizens on other visas (e.g. diplomatic student, visitors or visiting scholars) shall be classified as nonresidents. Service in the armed forces of the United States shall entitle the noncitizen to be classified as nonresident or resident on the same basis as a citizen." The impact of this change was to provide institutions with broader discretion in determining the residency status of prospective students according to the overall residency policy.

FISCAL IMPLICATIONS

The bill does not include an appropriation. Data on the size of the eligible group in New Mexico is currently not available, and the fiscal impact is indeterminate. To the extent this legislation would permit additional non-United States citizens who are legally living in the United States to attend New Mexico post-secondary institutions at resident tuition rates, then the bill could increase general fund expenditures for the higher education system.

ADMINISTRATIVE IMPLICATIONS

CHE notes a revision to rules and regulations governing residency for tuition purposes would be needed if this legislation is enacted.
