WHEREAS, it is necessary to protect the public welfare, which is also dependent on these other values and resources, and it is necessary to protect the economic well-being of the owners and users of such real property and surface resources; and

WHEREAS, an executive order of August 26, 2004 instructs federal agencies to take "appropriate account of and respect the interests of persons with ownership or other legally recognized interests in land and other natural resources" in their implementation of laws relating to natural resources; and

WHEREAS, owners of surface resources should be fully compensated for injury to their persons or damage to and loss of use and loss of value to their property resulting from mineral and energy exploration, development, production and transmission;

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE OF NEW MEXICO that New Mexico's congressional delegation and the United States secretary of the interior be requested to support legal and administrative reform to protect the rights of surface owners and decrease the surface damage done during energy development; and
