WHEREAS, on December 8, 2004, Elizabeth Shirley Baca was arrested in the city of Albuquerque for possession of a controlled substance, less than one ounce of marijuana, in violation of Section 30-31-23 NMSA 1978, a petty misdemeanor, and for possession of drug paraphernalia in violation of Section 30-31-25.1 NMSA 1978, a misdemeanor; and

9 WHEREAS, on December 8, 2004, Elizabeth Shirley Baca
10 admitted to the arresting officer that she occasionally smokes
11 marijuana, a controlled substance; and

WHEREAS, Article 4, Section 36 of the constitution of New Mexico provides, in pertinent part, that "All state officers . . . shall be liable to impeachment for crimes, misdemeanors and malfeasance in office . . . ";

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE OF NEW MEXICO that there are three grounds for impeachment of Elizabeth Shirley Baca, public regulation commissioner:

Ground 1. Elizabeth Shirley Baca committed the petty misdemeanor of possession of a controlled substance by both action and admission;

Ground 2. Elizabeth Shirley Baca committed the misdemeanor of possession of drug paraphernalia; and

Ground 3. Elizabeth Shirley Baca committed

malfeasance in office by violating her constitutional oath to support the laws of the state; and
