<u>Responses Received From</u> Human Services Department (HSD)

SUMMARY

House Bill 31 proposes to require Medicaid to reimburse licensed chiropractic physicians including the services of licensed doctors of oriental medicine for services rendered within their scope of practice.

SIGNIFICANT ISSUES

HSD reports that Medicaid does not currently reimburse for services provided by licensed chiropractors or licensed doctors of oriental medicine. Including reimbursement to chiropractors and licensed doctors of oriental medicine for their services would be an expansion to the

Medicaid program. Most states do not cover these services under their Medicaid program, as this is an optional service.

FISCAL IMPLICATIONS

By including chiropractors and doctors of oriental medicine to Medicaid's eligible providers and health care benefits, there would be a need for approximately \$3.1 million to support these new providers and services. This figure is based on 2% of all Medicaid recipients (both Fee-for service and managed care) having four (4) visits to a chiropractor or doctor of oriental medicine on an annual basis. The total expenditure is estimated to be \$3.1 million \$868 thousand from the state general fund and \$2.32 million from federal Medicaid participation. The funds would have to be recurring. However, there seems to be uncertainty at HSD since in 2005 the annual cost estimated for this service was \$7.5 million.

Without an appropriation the bill would be unfunded. In order to provide chiropractic and oriental medicine services, other Medicaid services would have to be cut or eliminated to remain within the appropriated budget.
