Synopsis of Bill

Senate Joint Memorial Bill 18 requests the Public Education Department (PED) and the State's Public Schools to educate students and support efforts to engage students in research, documentation of cultural knowledge, New Mexico's history, and culture of present day acequias. The local school district is requested to recognize the importance of acequia participation to assist the cultural identity of youth in traditional communities. Local School district is requested to allow youth participants excused absences for spring cleaning of such activities in their community. The local School District is requested to collaborate with community-based organizations such as the New Mexico acequia association to innovate service learning opportunities in a cultural environment. In addition, state agencies, and local government is requested to embrace that acequias remain strong, in promoting policies that support sustainability for benefit of future generations. Copies of Memorial 18 should be distributed to the Public Education Department and superintendents of state public school districts.
