16	Section 1. ONATE TRAINING CENTER COMPLEX CANTEEN
17	ESTABLISHMENTPOWERS AND DUTIESPROCEEDSAUDITS
18	A. The department of military affairs may establish
19	a canteen at the Onate training center complex in Santa Fe for
20	the morale, welfare and recreation of trainees and soldiers.
21	The canteen shall be established in accordance with rules of
22	the federal departments of the army and air force and the
23	national guard governing nonappropriated fund morale, welfare
24	and recreation activities. The department of military affairs
25	shall adopt and promulgate rules to carry out the provisions of

2	B. The canteen shall:
3	(1) be separate and apart from the state;
4	(2) be self-sufficient and not receive any
5	appropriations from the legislature;
6	(3) establish a system of bookkeeping and
7	accounting for the proper handling of money derived from its
8	operations; and
9	(4) establish bank accounts into which
10	proceeds from sales and other income of the canteen are
11	deposited and out of which obligations of the canteen are paid.
12	C. The canteen may:
13	(1) contract for goods and services; and
14	(2) hire necessary employees, who shall not be
15	state employees.
16	D. No obligations or contracts of the canteen shall
17	be considered to be obligations or contracts of the state.
18	E. The department shall require an annual
19	independent audit each year of the canteen's operations and may
20	require other audits as necessary. Audits shall be submitted
21	to the state auditor and the legislative finance committee
22	within ten days of receipt by the department.
23	F. Money derived from the operation of the canteen
24	is appropriated to the department for the operations of the
25	canteen and general welfare of soldiers and airmen of the New
