taxpayer as the taxpayer's principal place of residence.

B. To be eligible for the credit, the advanced treatment on-site liquid waste system must comply with the liquid waste disposal and treatment regulations of the department of environment and must be installed by a qualifying contractor as determined by the department of environment.

C. To claim the credit provided by this section the taxpayer must furnish, in a form to be determined by the taxation and revenue department, certification from the department of environment that the taxpayer's advanced treatment on-site liquid waste system complies with department of environment regulations and was installed by a qualifying contractor.

D. A taxpayer may deduct the credit provided by this section from the taxpayer's income tax liability for the taxable year in which the cost was incurred. If the amount of the credit exceeds the taxpayer's income tax liability, the excess credit may be carried forward for up to three years.

E. A husband and wife who file separate returns for a taxable year in which they could have filed a joint return may each claim only one-half of the credit that would have been allowed on a joint return.

F. As used in this section, "advanced treatment onsite liquid waste system" means an on-site liquid waste system that uses any process of wastewater treatment that removes a .165813.1
