17	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:								
18	Section 1. Section 17-1-14 NMSA 1978 (being Laws 1921,								
19	Chapter 35, Section 7, as amended by Laws 2005, Chapter 38,								
20	Section 1 and by Laws 2005, Chapter 177, Section 1) is amended

24	A. The state game commission shall have general								
25	control over the collection and disbursement of all money

collected or received under the state laws for the protection 2 and propagation of game and fish, which money shall be paid 3 over to the state treasurer to the credit of the game protection fund, unless otherwise provided by law, and the fund, including all earned income, shall not be transferred to another fund. Prior to depositing money into the game protection fund, the department of game and fish shall ensure 8 that an amount adequate to cover the cost of refunds allowed by 9 the provisions of Chapter 17 NMSA 1978 is held in a liability 10 suspense account. All refunds shall be made from the liability 11 suspense account. Money not needed to cover the cost of 12 refunds shall be deposited in the game protection fund at the 13 end of each month. Chapter 17 NMSA 1978 shall be guaranty to the person who pays for hunting and fishing licenses and permits that the money in that fund shall not be used for any purpose other than as provided in Chapter 17 NMSA 1978.

Β. The state game commission shall have authority to:

(1)establish and, through the director of the department of game and fish, to operate fish hatcheries for the purpose of stocking public waters of the state and to furnish fish fry and fingerlings to stock private waters, receipts from such sources to go into the game protection fund;

(2) declare closed seasons in any specified locality and on any species of game or fish threatened with .163685.1 - 2 -

2 (3) establish game refuges for the purpose of
3 providing safe sanctuaries in which game may breed and

5 provision to establish small refuges rather than large
6 preserves or to close large areas to hunting;

(4) purchase lands for game refuges where suitable public lands do not exist, to purchase lands for fish hatcheries and to purchase lands to be maintained perpetually as public hunting grounds, particularly lands suitable for waterfowl hunting, all such lands to be paid for from the game protection fund;

(5) receive by gift or bequest, in the name and on behalf of the state, lands suitable for game refuges, hunting grounds, fish hatcheries or for any other purpose necessary to carry out the provisions of Chapter 17 NMSA 1978;

(6) apply for and accept any state, federal or private funds, grants or donations from any source for game and fish programs and projects;

(7) designate certain areas as rest grounds for migratory birds, in which hunting shall be forbidden at all times or at such times as the state game commission shall provide, it being the purpose of this provision not to interfere unduly with the hunting of waterfowl but to provide havens in which they can rest and feed without molestation; .163685.1

1 provided the fees shall not exceed the costs of administration 2 associated with the licenses, permits or certificates; 3 (14) permit, regulate or prohibit the 4 commercial taking or capturing of native, free-ranging 5 amphibians or reptiles not specifically protected by law, 6 except for rattlesnake roundups, collection of fish bait and 7 lizard races; 8 (15) adopt rules to control, eradicate or 9 prevent the spread of a contagious disease, pest or parasite, 10 including chronic wasting disease, to or among game animals. 11 The rules shall include provisions for: 12 (a) notification to the department of 13 game and fish of the diagnosis or suspected presence of a 14 contagious disease; 15 (b) examination by the state 16 veterinarian or the state veterinarian's designee of suspected 17 infected game animals; 18 (c) quarantine, treatment or destruction 19 of an infected game animal; 20 disinfection and isolation of a (d) 21 licensed private park where an infected game animal has been; 22 and 23 (e) indemnification and destruction of a 24 protected game animal; 25 (16) as necessary, designate areas of the .163685.1 - 5 -

state in which bear-proof garbage containers are required on public and private lands to reduce potential human-bear interactions; and

(17) pursuant to appropriation by the legislature, expend money from the game protection fund, [and] the habitat management fund or from any other source for the 7 improvement, maintenance, development and operation of property 8 for fish and wildlife habitat management; for the development and distribution of information; and for habitat conservation 10 for the benefit of any nondomestic animal species native to New 11 Mexico.

C. The director of the department of game and fish shall exercise all the powers and duties conferred upon the state game and fish warden by all previous statutes now in force not in conflict with Chapter 17 NMSA 1978.

The state game commission shall have authority D. to prohibit all hunting in periods of extreme forest fire danger, at such times and places as may be necessary to reduce the danger of destructive forest fires.

Ε. The hunting, pursuing, capturing, killing or wounding of any game animals, birds or fish in or upon any game refuge, rest ground or closed water or closed area or during any closed season established or proclaimed by the state game commission in accordance with the authority conferred in Chapter 17 NMSA 1978 constitutes a misdemeanor and shall be .163685.1
