22	licensed doctors of oriental medicine, licensed chiropractic
23	physicians and licensed dental hygienists in collaborating
24	practice, to persons eligible for public assistance programs
25	under the federal act.

Β. Subject to appropriation and availability of 2 federal, state or other funds received by the state from public 3 or private grants or donations, the medical assistance division of the department may by rule provide medical assistance, including assistance in the payment of premiums for medical or long-term care insurance, to children up to the age of twelve 7 if not part of a sibling group; children up to the age of 8 eighteen if part of a sibling group that includes a child up to 9 the age of twelve; and pregnant women who are residents of the 10 state of New Mexico and who are ineligible for public 11 assistance under the federal act. The department, in 12 implementing the provisions of this subsection, shall:

(1)establish rules that encourage pregnant women to participate in prenatal care; and

(2) not provide a benefit package that exceeds the benefit package provided to state employees."

Section 2. Section 27-2-12.3 NMSA 1978 (being Laws 1987, Chapter 269, Section 1, as amended) is amended to read:

"27-2-12.3. MEDICAID REIMBURSEMENT--EQUAL PAY FOR EQUAL PHYSICIANS', DENTISTS', OPTOMETRISTS', PODIATRISTS', LICENSED DOCTORS' OF ORIENTAL MEDICINE AND PSYCHOLOGISTS' SERVICES.--The [human services] department shall establish a rate for the reimbursement of physicians, dentists, optometrists, podiatrists, licensed doctors of oriental medicine and psychologists for services rendered to medicaid patients that .166887.1 - 2 -
