## Synopsis of Bill

House Memorial 16 proclaims Thursday, February 8, 2007, as "ARCA DAY" at the New Mexico House of Representatives and requests that recognition and appreciation be extended to ARCA in honor of its fiftieth anniversary.

- ARCA offers its recipients many options, including community living, family living, employment, community-inclusion services and a statewide prader willi: project; and

 ARCA's compassionate work force of over six hundred employees helps individuals with disabilities fulfill their daily needs, make meaningful choices, connect with the community and achieve their dreams.
