SUMMARY

Synopsis of Bill

Senate Bill 1078 amends the film production credit to disallow the credit for G or PG rated films that depicts or includes persons smoking. The bill also requires the film production company to submit in writing their intent to refrain from depicting or including persons smoking for G or PG rated films.

There is no effective date so the default effective date is June 15, 2007.

FISCAL IMPLICATIONS

The fiscal implications are difficult to determine. Many of the films produced in New Mexico are R-rated or PG-13. Of 17 films that received the credit that information about ratings could be found, only 2 were PG and none were G-rated.

SIGNIFICANT ISSUES

According to an article in New Scientist, seeing stars in movies smoking is a factor in 52 percent of adolescents who begin smoking, making it a significant health issue. The authors and others think that movies with smoking should be automatically rated R for mature audiences. (http://www.newscientist.com/article.ns?id=dn3812)

Mississippi State University developed a survey of attitudes and perceptions about smoking and has released a study "Attitudes About Smoking in the Movies." From the executive summary:

More than a decade of research has established that U.S. movies are a major recruiter of new teen smokers in the United States: about 390,000 each year, of whom 120,000 will ultimately die from tobacco-related diseases unless current trends are altered. This national survey of adults demonstrates substantial and growing public and parental support for voluntary policy changes by Hollywood to reduce this toll, including an R-rating for almost all future tobacco scenes.

NM Film Office:

1) There is no way of knowing what rating a film will be issued until after the film has been completed – well after a film has applied for the New Mexico Film Production Tax Rebate.

2) Utilizing the voluntary Motion Picture Association of America (MPAA)– administered rating system is an unlawful delegation of legislative authority to private entities, which is supported by a large body of federal and state case law. The MPAA Rating System is voluntary and strictly advisory with no force of local, state or federal law and cannot legally be mandated or enforced by government or an agency of government, be it federal, state or local.

CONFLICT, DUPLICATION, COMPANIONSHIP, RELATIONSHIP

Relates to HB757 and SB802, which change features of the tax credit.
