8. Renumber the succeeding paragraphs accordingly.
9. On page 11, line 4, after "of", strike the remainder of the line.
10. On page 11, line 7, after the semicolon, insert "and".
11. On page 11, lines 8 through 10, strike Paragraph (3) in its entirety.
12. Renumber the succeeding paragraph accordingly.
13. On page 11, line 11, after the first occurrence of "of", strike the remainder of the line and strike line 12 up to "justice".

19. Renumber the succeeding paragraph accordingly.
20. On page 12, line 14, after the first occurrence of "of", strike the remainder of the line and strike line 15 up to "justice".
21. On page 15, line 25, strike "of" and insert in lieu thereof "from".
22. On page 16, line 1, before the period, insert "in the amount of one hundred thousand dollars (\$100,000) per month during fiscal year 2008 and subsequent fiscal years".
23. On page 16, line 23, after "distribution", strike the remainder of the line and strike line 24 up to "all" and insert in lieu thereof "pursuant to the provisions of the Tax Administration Act".
