AN ACT

MAKING APPROPRIATIONS AND AUTHORIZING EXPENDITURES FOR THE
STATE FAIR COMMISSION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. SHORT TITLE.--This act may be cited as the
"State Fair Commission Appropriation Act".

Section 2. DEFINITION.--As used in the State Fair
Commission Appropriation Act, "other state funds" means:

A. unencumbered balances in state agency accounts
appropriated by the General Appropriation Act of 2007; and

B. all revenue available to state agencies from
sources other than the general fund and federal funds.

Section 3. FORMAT.--The general format of the
appropriations set forth in the State Fair Commission
Appropriation Act with respect to symbols used, column headings

- (d) Output: Number of total attendees at annual state fair event 750,000
