16	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
17	Section 1. AUTHORIZATION OF ISSUANCE OF BONDSPursuant
18	to the provisions of Section 5-15-21 NMSA 1978, the legislature
19	authorizes the issuance of bonds not to exceed six hundred
20	twenty-nine million dollars (\$629,000,000) in net proceeds as
21	adjusted for inflation, secured by a gross receipts tax
22	increment attributed to the imposition of the state gross
23	receipts tax for the SunCal tax increment development project,
24	subject to:
25	A. the determination that has been made by the New

Mexico finance authority that the proceeds of the bonds issued 2 pursuant to this authorization will be used for the SunCal tax 3 increment development project in accordance with the 4 development plan;

Β. the review by the New Mexico finance authority of the master indenture prior to issuance of any bonds; and

C. the review by the New Mexico finance authority of any proposed amendments to the master indenture prior to the issuance of any bonds subsequent to such amendments.

Section 2. DURATION OF AUTHORIZATION. -- The duration of the authorization for issuance of bonds in this act is unlimited, unless and until this act is repealed or modified by the legislature.

Section 3. CERTAIN CAPITAL PROJECTS PROHIBITED .--

Α. The legislature shall not approve or authorize any capital outlay projects within a SunCal tax increment development district during the period that any bonds issued pursuant to Section 1 of this act are outstanding for that specific district, except for those buildings or facilities that are owned by the state or one of its agencies, institutions or political subdivisions and that are:

> public school buildings or facilities; (1)
