I request that the following be funded:

- to the department of environment

BLANCO MDWC & MSWA INFRA

five hundred thousand dollars (\$500,000) to plan, design and construct infrastructure for the water transmission system for the Blanco mutual domestic water consumers and mutual sewage works association in San Juan county

NORTH STAR MDWCA INFRA IMPROVE

four hundred thousand dollars (\$400,000) to plan, design and construct infrastructure improvements to the water transmission and distribution system for North Star mutual domestic water consumers association in San Juan county

SOUTHSIDE MDWA TREATMENT UNIT CONSTRUCT

three hundred thousand dollars (\$300,000) to design and construct a treatment unit for the Southside mutual domestic water association in San Juan county

AZTEC WATER SYS CONTRUCT

five hundred thousand dollars (\$500,000) to plan, design, construct and purchase a water system, including water tank, transmission line, land and rights of way, in Aztec in San Juan county

BLOOMFIELD N 1ST ST/NORTH HEIGHTS WATER/WASTEWATER

six hundred thousand dollars (\$600,000) to plan, design and construct improvements to the water and wastewater systems on north First street and the North Heights area in Bloomfield in San Juan county

one million dollars (\$1,000,000) to plan, design and construct a wastewater system in Flora Vista in San Juan county

fifty thousand dollars (\$50,000) to equip and furnish a law enforcement center in San Juan county

AZTEC ANIMAS RIVER REC/TRAILS/BRIDGE PROJECT

five hundred thousand dollars (\$500,000) to plan, design, construct, purchase and equip the Animas river recreational facilities, trails and bridge project in Aztec in San Juan county

SAN JUAN CO COMM AUTHORITY IMPROVE

one hundred thousand dollars (\$100,000) to plan, design, construct, furnish, equip and improve the communications authority facility in San Juan county

BLOOMFIELD BALL PARKS EQUIP & LIGHT

three hundred thousand dollars (\$300,000) to purchase equipment and to install and construct lighting for the ball field in the ball parks in Bloomfield in San Juan county

BLOOMFIELD FIRE AND POLICE VEHICLES INFO TECH

two hundred seventy-four thousand dollars (\$274,000) to purchase and install information technology, including related equipment, furniture and infrastructure, for fire and police vehicles in Bloomfield in San Juan county

FARMINGTON DOMESTIC VIOLENCE SHELTER

seventy-five thousand dollars (\$75,000) to design and construct a domestic violence shelter in Farmington in San Juan county

two hundred thousand dollars (\$200,000) to replace the roof at Blanco elementary school in the Bloomfield school district in San Juan county

BLOOMFIELD EARLY CHILDHOOD CENTER PLAYGROUND EQUIP

eighty thousand dollars (\$80,000) to design and install playground equipment at the Bloomfield early childhood center in the Bloomfield school district in San Juan county
