SUMMARY

Synopsis of Bill

House Bill 201 appropriates \$500.0 from the general fund to the Board of Regents of New Mexico Highlands University to fund the Ben Lujan Institute for Public Policy.

FISCAL IMPLICATIONS

The appropriation of \$500.0 contained in this bill is a recurring expense to the general fund. Any unexpended or unencumbered balance remaining at the end of fiscal year 2009 shall revert to the general fund.

This request was submitted by NMHU to the New Mexico Higher Education Department, but was not included in the Department's recommendations for FY09.

The HED's evaluation table of FY09 Research and Public Service Projects provided to the LFC classifies this project as a "does not fit within HED priorities for Higher Education" project. Reasons for this classification decision are not provided. (LFC Report 07-20, Higher Education Department Review of Selected Research and Public Service Projects, January 12, 2008, Table 4, p73.)

SIGNIFICANT ISSUES

NMHU states that House Bill 201 provides funding to:

- create a year-long Principals academy for 25 promising teacher leaders;
- research, publish and disseminate three major policy publications;
- create an Institute for 50 youth leaders dealing with NM policy issues; and
- develop a curriculum for use by NM schools dealing with youth entrepreneurship.

According to NMHU, House Bill 201 would increase the general fund operating budget by \$89.3 for this program. Laws of 2007 provided \$312,700 for this program. The appropriation is consistent with the University Strategic plan and assists with the university mission of integrating education, research, public service, and economic development.

The HED reports:

The Ben Lujan Leadership and Public Policy Institute (BLLPPI) was created to assist in shaping public policy throughout New Mexico at many levels. Among those areas targeted are: health care, nutrition, parent and community engagement, substance abuse, and PreK-20 education.

The institute bridges the gap between academic scholarship and policy development through its service to public and private sector clients and through its independent research agenda focused on New Mexico's needs. The BLLPPI has also expanded its mission to focus on helping develop a new generation of emerging leaders. All of this is accomplished by creating a series of collaborative opportunities for participation by students and other activities such as seminars, focus groups, research projects, service learning projects, leadership camps, program evaluation, and public outreach.

The goals of the BLLPPI are more comprehensively met through numerous collaborations with other leaders, organizations, policy institutes, community based organizations, and other institutions of higher education. The ultimate goal of the institute is to improve education in New Mexico while preparing leaders to meet the challenges within our state and nation.
