#### SUMMARY

#### Synopsis of Bill

House Bill 450 appropriates two hundred thousand dollars(\$200,0000 from the General Fund to the Board of Regents of New Mexico Institute of Mining and Technology (NM Tech) for expenditure in FY09 for the following purposes:

- \$100,000 for expenses related to enrolling seven public school teachers who teach mathematics and science in a twenty-month Masters of Science teaching program; and
- \$100,000 for data research and analysis of students who have participated in programs that prepared them for careers in mathematics, engineering and the sciences.

#### FISCAL IMPLICATIONS

The appropriation of two hundred thousand dollars (\$200,000) contained in this bill is a recurring expense to the General Fund. Any unexpended or unencumbered balance remaining at the end of Fiscal Year 2009 shall revert to the General Fund.

#### House Bill 450 – Page 2

This request was not submitted by NM Tech to the New Mexico Higher Education Department for review and is not included in the Department's funding recommendation for FY09.

The HED's evaluation table of FY09 Research and Public Service Projects provided to the LFC classifies this project as a "supports state priorities" project. Reasons for this classification decision are not provided. (LFC Report 07-20, Higher Education Department Review of Selected Research and Public Service Projects, January 12, 2008, Table 4, p73.)

### **SIGNIFICANT ISSUES**

# HED states:

House Bill would establish a scholarship program targeting New Mexico's public school teachers who are teaching math and science. NM Tech offers a Master of Science Teaching program that addresses a critical educational need of science and mathematics teachers in New Mexico by making standards-based mathematic instruction accessible to teachers and subsequently their students.

#### PED notes:

The Master of Science for Teachers program has experienced significant growth in the last several years. It currently has 125 actively enrolled teachers.
