11	REQUESTING A STUDY OF OPTIONS FOR SECURING ADDITIONAL FEDERAL
12	FUNDING FOR UNCOMPENSATED INDIGENT PATIENT CARE IN NEW MEXICO

15	WHEREAS, New Mexico hospitals bear a substantial financial
16	burden in providing uncompensated care to indigents; and
17	WHEREAS, adequate and equitable funding of hospitals is of
18	critical importance to all New Mexicans; and
19	WHEREAS, increased federal assistance in funding hospitals
20	would relieve the burden that New Mexico hospitals bear in
21	providing uncompensated care to indigent persons; and
22	WHEREAS, increased federal assistance in funding hospitals
23	would also relieve the disproportionate burden that New Mexico
24	hospitals bear in providing care to illegal aliens by virtue of
25	being a border state; and

WHEREAS, increased federal funding for uncompensated care is critical at a time, such as this one, when uninsured patients often receive care in the state's hospital emergency rooms and hospitals, and the hospitals, in turn, request appropriations to offset the cost of providing care to those who cannot or will not pay; and

WHEREAS, the current funding of the university of New Mexico hospitals is inequitable, in that funding comes from a mill levy on Bernalillo county property owners but the hospitals serve indigent patients from throughout the state;

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE OF NEW MEXICO that the New Mexico health policy commission be requested to convene a task force to study hospital funding; and

BE IT FURTHER RESOLVED that the task force comprise nine members appointed by the executive branch, including the medicaid director or the medicaid director's designee, a representative from the university of New Mexico hospitals, a member from the New Mexico health policy commission and members with expertise in medicaid funding and hospital funding; and

BE IT FURTHER RESOLVED that the task force study options for securing additional federal funding for uncompensated indigent patient care in New Mexico hospitals, including the option of requesting an expansion of the existing federal waiver for the state coverage insurance program; and
