[NEW MATERIAL] VETERANS MUSEUM DIVISION 6 CREATED--LOCATION--PROPERTY.--7 Α. The "veterans museum division" is created in the 8 cultural affairs department. The principal facility of the 9 division is the "New Mexico veterans museum" located in Las 10 The site shall be held in the name of the state. Cruces. 11 Β. All property, real or personal, now held or 12 subsequently acquired for the operation of the museum shall be 13 under the control and authority of the board. 14 C. Funds or other property received by gift, 15 endowment or legacy shall remain under the control of the board 16 and shall, upon acceptance, be employed for the purpose 17 specified. 18 Section 4. [NEW MATERIAL] BOARD OF TRUSTEES CREATED--19 APPOINTMENTS--TERMS--OFFICERS.--20 The "board of trustees of the New Mexico Α. 21 veterans museum" is created. The board shall consist of eleven 22 voting members who are residents of New Mexico. One of the 23 voting members shall be the secretary of veterans' services or 24 that secretary's designated representative. Ten voting members 25 shall be appointed by the governor with the advice and consent .174482.1SA - 2 -

In making the appointments, the governor shall 2 appoint at least three members from each congressional district 3 and give due consideration to the ethnic and geographic 4 diversity of the state. No more than five of the ten appointed 5 members shall be from the same political party. At least five of the members shall be armed forces veterans, one each from: 6 7 the New Mexico national guard; (1) 8 (2) the United States army; 9 (3) the United States navy; 10 (4) the United States air force; and 11 (5) the United States marine corps. 12 Of the initial appointees, four members shall be Β. 13 appointed for four-year terms, four members shall be appointed 14 for three-year terms and two members shall be appointed for 15 two-year terms. All subsequent appointed members shall be 16 appointed for four-year terms. 17 A majority of the board members currently C. 18 serving shall constitute a quorum at any meeting or hearing. 19 D. Any appointed member failing to attend three 20 consecutive meetings after receiving proper notice shall be 21 recommended for removal by the governor. The governor may also 22 remove any appointed member of the board for neglect of any 23 duty required by law, for incompetency, for unprofessional 24 conduct or for violating any provisions of the Veterans Museum 25 Act. 1 appoint another member to complete the unexpired term. 2 Ε. The secretary of cultural affairs shall be an 3 ex-officio nonvoting member of the board. 4 F. The governor shall designate the president of 5 the board, who shall serve in that capacity at the pleasure of 6 the governor. 7 G. Appointed members of the board are entitled to per diem and mileage as provided in the Per Diem and Mileage 8 Act but shall receive no other compensation, perquisite or 9 10 allowance. 11 Section 5. [NEW MATERIAL] BOARD--POWERS--DUTIES.--The 12 board shall: 13 exercise trusteeship over the collections of the Α. 14 museum; 15 accept and hold title to all property for the Β. 16 museum's use; 17 C. review annually the performance of the director 18 and report its findings to the secretary; 19 D. enter into agreements or contracts with private 20 or public organizations, agencies or individuals for the 21 purpose of obtaining real or personal property for the museum's 22 use; 23 Ε. authorize the director to solicit and receive 24 funds or property of any nature for the development of the 25 museum, its collections and its programs; .174482.1SA

1 F. adopt such rules as may be necessary to carry 2 out the provisions of the Veterans Museum Act; and 3 establish policy, determine the mission and G. direct the development of the museum. 4 5 Section 6. [NEW MATERIAL] DIRECTOR--APPOINTMENT--6 QUALIFICATIONS .--7 Subject to the authority of the secretary, the Α. administrative and executive officer of the division and the 8 9 museum is the "director" of the division. 10 Β. The secretary shall appoint the director with 11 the approval of the governor from a list of qualified finalists 12 provided by the board of trustees. 13 The position of director shall require previous C. 14 experience in museum administration. 15 [<u>NEW MATERIAL</u>] DIRECTOR--POWERS--DUTIES.--Section 7. 16 Subject to the policies agreed to by the board, the director: 17 shall be responsible for the operation of the Α. 18 museum in accordance with all appropriate statutes and rules; 19 Β. shall develop exhibits and programs displaying 20 New Mexico veterans history for the benefit of the public and 21 with particular concern for the interests of the schools of the 22 state; 23 C. shall acquire by donation or other means of 24 acquisition any collections and related materials appropriate 25 to a veterans museum and shall direct research as is .174482.1SA

appropriate to render the collections of benefit to the public;

D. shall employ such professional staff and other employees as are necessary to the operation of the museum in accordance with the provisions of the Personnel Act;

E. may solicit and receive funds or property of any nature for the development of the museum;

F. may enter into contracts with public or private organizations, agencies or individuals for the performance of services related to the location, preservation, development, study or salvage of historical New Mexico veterans materials;

G. shall provide an office in the museum for use by the veterans' services department to provide services to New Mexico veterans;

H. shall cooperate with institutions of higher education and other agencies and political subdivisions of municipal, state and federal governments to establish, maintain and extend the programs of the museum;

I. may, as authorized by the board, lend collection materials to qualified institutions and agencies for purposes of exhibition and study and borrow collection materials from other institutions and agencies for the same purpose;

J. subject to the provisions of Section 8 of the Veterans Museum Act, shall impose and collect admission fees and conduct retail sales as are normal for the operation of the museum;

L. shall perform other appropriate duties as may be delegated by the governor, the secretary or the board or as may be provided by law.

Section 8. [<u>NEW MATERIAL</u>] MUSEUM ADMISSION POLICY.--The board, the secretary of cultural affairs and the director shall establish and implement a policy to permit New Mexico residents age sixty years and older to enter all publicly accessible exhibit and program areas of the museum, except special exhibits and programs where commissions or royalties are paid by contract, free of charge every Wednesday that is not a holiday that the museum is open.

Section 9. Section 9-4A-4 NMSA 1978 (being Laws 2004, Chapter 25, Section 4, as amended) is amended to read:

"9-4A-4. DEPARTMENT CREATED.--The "cultural affairs department" is created in the executive branch. The department is a cabinet department and includes the following divisions:

Α.	the administrative services division;
Β.	the arts division;

D.	the library division;
E.	the Hispanic cultural division;
F.	the farm and ranch heritage museum division;
