AN ACT

RELATING TO BOARDS AND COMMISSIONS; EXTENDING THE SUNSET DATES FOR CERTAIN BOARDS AND COMMISSIONS; RECONCILING MULTIPLE AMENDMENTS TO THE SAME SECTION OF LAW IN LAWS 2003.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 9-15-51 NMSA 1978 (being Laws 2003, Chapter 166, Section 4 and Laws 2003, Chapter 170, Section 4, as amended) is amended to read:

"9-15-51. TERMINATION OF AGENCY LIFE--DELAYED REPEAL.--
The office of military base planning and support and the military base planning commission are terminated on July 1, [2009] 2011 pursuant to the provisions of the Sunset Act. The office and the commission shall continue to operate according to the provisions of [~~this act~~] Sections 9-15-48 through 9-15-51 NMSA 1978 until July 1, [2010] 2012. Effective July 1,

21 of the Professional Psychologist Act until July 1, [~~2010~~] 2016.
22 Effective July 1, [~~2010~~] 2016, the Professional Psychologist
23 Act is repealed."

11 The board of pharmacy is terminated on July 1, [~~2009~~] 2015
12 pursuant to the Sunset Act. The board shall continue to
13 operate according to the provisions of the Pharmacy Act until
14 July 1, [~~2010~~] 2016. Effective July 1, [~~2010~~] 2016, the
15 Pharmacy Act is repealed."

16 Section 9. Section 61-12B-16 NMSA 1978 (being Laws 1984,
17 Chapter 103, Section 17, as amended) is amended to read:

18 "61-12B-16. TERMINATION OF BOARD--DELAYED REPEAL.--The
19 advisory board of respiratory care practitioners is terminated
20 on July 1, [~~2009~~] 2015 pursuant to the Sunset Act. The board
21 shall continue to operate according to the provisions of the
22 Respiratory Care Act until July 1, [~~2010~~] 2016. Effective July
23 1, [~~2010~~] 2016, the Respiratory Care Act is repealed."
