3 As necessary during the year, the division shall Β. transfer an amount from the [law enforcement protection] fund to the peace officers' survivors fund that enables the balance of the peace officers' survivors fund to be maintained at a minimum balance of three hundred fifty thousand dollars (\$350,000). 8

C. Unless increased pursuant to Subsections E and F of this section, the division shall determine the rate of distribution of money remaining in the fund to each tribal, municipal and university police and county sheriff's department as follows:

all municipal police and county sheriff's (1)departments shall be rated by class pursuant to this paragraph in accordance with populations established by the most recently completed decennial census; provided that the population of any county shall not include the population of any municipality within that county that has a municipal police department. The rate of distribution to which a municipal police or county sheriff's department is entitled is the following:

After distributions are determined in accordance D. with Subsection A, Subsection B and Paragraphs (1) and (2) of Subsection C of this section, if the balance in the fund is 7 insufficient to permit the total allocations provided by 8 Paragraphs (3) and (4) of Subsection C of this section, the division shall reduce that allocation to the maximum amount permitted by available money.

E. For fiscal year 2010 and each fiscal year thereafter, the division shall certify a total amount equal to the higher of the amount that would be certified pursuant to Subsection C of this section or an amount to be determined by adding:

(1) the total increase in the fund receipts in the previous fiscal year minus the transfer made pursuant to Subsection B of this section; and

(2) the total distribution pursuant to Subsection C of this section for the previous fiscal year.

F. If the calculation pursuant to Subsection E of this section results in an increased total distribution, the division shall adjust the distributions made pursuant to Paragraph (1) of Subsection C of this section for each department in proportion to the increase in the total .174579.1
