RELATING TO COURT PROCEEDINGS; ENACTING THE UNIFORM UNSWORN FOREIGN DECLARATIONS ACT; AMENDING THE DEFINITION OF PERJURY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

[NEW MATERIAL] SHORT TITLE.--Sections 1 Section 1. through 8 of this act may be cited as the "Uniform Unsworn Foreign Declarations Act".

- Section 2. [NEW MATERIAL] DEFINITIONS.--As used in the Uniform Unsworn Foreign Declarations Act:
- "boundaries of the United States" means the Α. geographic boundaries of the United States, Puerto Rico, the United States Virgin Islands and any territory or insular possession subject to the jurisdiction of the United States;
- "law" includes the federal or a state constitution, a federal or state statute, a judicial decision .176691.3

jurisdiction of the United States. The Uniform Unsworn Foreign Declarations Act does not apply to a declaration by a declarant who is physically located on property that is within the boundaries of the United States and subject to the jurisdiction of another country or a federally recognized Indian tribe.

Section 4. [NEW MATERIAL] VALIDITY OF UNSWORN DECLARATION. --

- Except as otherwise provided in Subsection B of this section, if a law of New Mexico requires or permits use of a sworn declaration, an unsworn declaration meeting the requirements of the Uniform Unsworn Foreign Declarations Act has the same effect as a sworn declaration.
- The Uniform Unsworn Foreign Declarations Act does not apply to:
 - a deposition; (1)
 - an oath of office; (2)
- an oath required to be given before a (3) specified official other than a notary public;
- a declaration to be recorded in records affecting real property pursuant to Section 14-9-1 or 14-9-7 NMSA 1978; or
- an oath required for self-proved wills by (5) Section 45-2-504 NMSA 1978.

Section 8. [NEW MATERIAL] RELATION TO ELECTRONIC

SIGNATURES IN GLOBAL AND NATIONAL COMMERCE ACT. The Uniform

Unsworn Foreign Declarations Act modifies, limits and

supersedes the federal Electronic Signatures in Global and

National Commerce Act, 15 U.S.C. Section 7001, et seq., but

does not modify, limit or supersede Section 101(c) of that act,

15 U.S.C. Section 7001(c), or authorize electronic delivery of

any of the notices described in Section 103(b) of that act, 15

U.S.C. Section 7003(b).

Section 9. Section 30-25-1 NMSA 1978 (being Laws 1963, Chapter 303, Section 25-1) is amended to read:

"30-25-1. PERJURY.--

A. Perjury consists of making a false statement under oath, [or] affirmation or penalty of perjury, material to the issue or matter involved in the course of any judicial, administrative, legislative or other official proceeding or matter, knowing such statement to be untrue.

 $\underline{\mathtt{B.}}$ Whoever commits perjury is guilty of a fourth degree felony."

Section 10. EFFECTIVE DATE.--The effective date of the provisions of this act is July 1, 2009.
