16	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
17	Section 1. Laws 2006, Chapter 111, Section 67 is amended

19	"Section 67. VOTING MACHINESSECRETARY OF STATEGENERAL
20	FUNDNotwithstanding the provisions of Sections 1-9-8 and
21	1-9-17 through 1-9-19 NMSA 1978, eleven million dollars
22	(\$11,000,000) is appropriated from the general fund to the
23	secretary of state for expenditure in fiscal years 2006 through
24	2008 for the purchase and installation of voting systems for

1	booths, to meet the requirements of Section 1-9-7.1 NMSA 1978
2	contingent on an amendment to that section by the second
3	session of the forty-seventh legislature to require the use of
4	voting systems that use paper ballots becoming law. In
5	addition to the purchase and installation of voting systems
6	statewide, the general fund appropriation in this section may
7	also be expended for election-related advertising and other
8	voter education and, notwithstanding the 2008 limit on the
9	expenditure period for this appropriation, may also be expended
10	to reimburse San Juan county in the amount of thirty-six
11	thousand five hundred forty dollars (\$36,540) for costs
12	incurred by San Juan county in calendar year 2000 related to
13	implementing the voter registration and election management
14	system. Subject to review and approval by the department of
15	finance and administration pursuant to Sections 6-3-23 through
16	<u>6-3-25 NMSA 1978 and notwithstanding any provision in those</u>
17	sections to the contrary, the secretary of state may request
18	such budget adjustments for the current or any previous fiscal
19	year as are necessary to effectuate the provisions of this
20	section. Any unexpended or unencumbered balance remaining on
21	January 1, 2008 shall revert to the general fund."

Section 2. EMERGENCY.--It is necessary for the public peace, health and safety that this act take effect immediately.
