AN ACT

RELATING TO SCHOOL PERSONNEL; REQUIRING ANNUAL PROFESSIONAL
DEVELOPMENT REPORTS TO THE LEGISLATIVE EDUCATION STUDY COMMITTEE
AND THE LEGISLATIVE FINANCE COMMITTEE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 22-10A-19.1 NMSA 1978 (being Laws
2004, Chapter 27, Section 25) is amended to read:

"22-10A-19.1. PROFESSIONAL DEVELOPMENT--SYSTEMIC
FRAMEWORK--REQUIREMENTS--DEPARTMENT DUTIES.--

A. The department shall develop a systemic framework
for professional development that provides training to ensure
quality teachers, school principals and instructional support
providers and that improves and enhances student achievement.
The department shall work with licensed school employees, the
[~~commission on~~] higher education department and institutions of

1 higher education to establish the framework.

2 B. The framework shall include:

3 (1) the criteria for school districts to apply
4 for professional development funds, including an evaluation
5 component [~~that will~~] to be used by the department in approving
6 school district professional development plans; and

7 (2) guidelines for developing extensive
8 professional development activities for school districts that:

9 (a) improve teachers' knowledge of the
10 subjects they teach and [~~the~~] their ability to teach those
11 subjects to all of their students;

12 (b) are an integral part of the public
13 school and school district educational plans for [~~improving~~]
14 student [~~achievement~~] success;

15 (c) provide teachers, school
16 administrators and instructional support providers with the
17 strategies, support, knowledge and skills to help all students
18 meet New Mexico academic standards;

19 (d) are high quality, sustained,
20 intensive and focused on the classroom; and

21 (e) are developed and evaluated
22 regularly with extensive participation of school employees and
23 parents.

24 C. The department, in conjunction with school
25 districts and charter schools, shall compile and report

1 statewide professional development activities related to the
2 prior school year to the legislative education study committee
3 and the legislative finance committee no later than December 15
4 of each year. The report shall include all professional
5 development activities that were provided to teachers, school
6 administrators, instructional support providers and department
7 staff from all state and federal funding sources. The report
8 shall include:

9 (1) a summary of the professional development
10 activities provided and by whom they were provided;

11 (2) evaluations showing the degree to which
12 the professional development activities satisfied the
13 guidelines established by the department pursuant to the
14 requirements of this section; and

15 (3) a summary of funds expended for
16 professional development from each funding source by public
17 school districts, charter schools and the department.

18 D. The department shall make any changes to the
19 system of accounting and budgeting for all public schools and
20 school districts necessary to fulfill this requirement."
