SENATE BILL 341

AN ACT

RELATING TO MOTOR VEHICLES; PROHIBITING THE OPERATION OF A
MOTOR VEHICLE WHILE READING, WRITING OR SENDING ELECTRONIC
MESSAGES; PROVIDING A PENALTY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. A new section of the Motor Vehicle Code,
Section 66-7-358.1 NMSA 1978, is enacted to read:

"66-7-358.1. [NEW MATERIAL] TEXT-BASED COMMUNICATION
PROHIBITED.--

A. A person shall not operate a motor vehicle while
using an electronic wireless communications device to write,
send or read a text-based communication except:

- (1) to report illegal activity;
- (2) to summon medical or other emergency help;
- (3) to prevent injury to a person or property;

1 (4) while the motor vehicle is lawfully
2 parked;

3 (5) in the operation of an authorized
4 emergency vehicle; or

5 (6) to relay information between a transit or
6 for-hire operator and that operator's dispatcher when the device
7 is permanently affixed to the vehicle.

8 B. For purposes of this section, a person is not
9 writing, reading or sending a text-based communication if the
10 person reads, selects or enters a telephone number or name in a
11 device for the purpose of making or receiving a telephone call.

12 C. The penalty for violation of the provisions of
13 this section is provided in Section 66-8-116 NMSA 1978."

14 Section 2. Section 66-8-116 NMSA 1978 (being Laws 1978,
15 Chapter 35, Section 524, as amended) is amended to read:

16 "66-8-116. PENALTY ASSESSMENT MISDEMEANORS--
17 DEFINITION--SCHEDULE OF ASSESSMENTS.--

18 A. As used in the Motor Vehicle Code, "penalty
19 assessment misdemeanor" means violation of any of the following
20 listed sections of the NMSA 1978 for which, except as provided
21 in Subsections D and E of this section, the listed penalty
22 assessment is established:

12 B. The term "penalty assessment misdemeanor" does not
13 include a violation that has caused or contributed to the cause
14 of an accident resulting in injury or death to a person.

15 C. When an alleged violator of a penalty assessment
16 misdemeanor elects to accept a notice to appear in lieu of a
17 notice of penalty assessment, a fine imposed upon later
18 conviction shall not exceed the penalty assessment established
19 for the particular penalty assessment misdemeanor and probation
20 imposed upon a suspended or deferred sentence shall not exceed
21 ninety days.

22 D. The penalty assessment for speeding in violation
23 of Paragraph (4) of Subsection A of Section 66-7-301 NMSA 1978
24 is twice the penalty assessment established in Subsection A of
25 this section for the equivalent miles per hour over the speed

1 limit.

2 E. Upon a second conviction for operation without a
3 permit for excessive size or weight pursuant to Section
4 66-7-413 NMSA 1978, the penalty assessment shall be two hundred
5 fifty dollars (\$250). Upon a third or subsequent conviction,
6 the penalty assessment shall be five hundred dollars (\$500)."
