11	CREATING A JOINT INTERIM PUBLIC SCHOOL TRANSPORTATION TASK
12	FORCE; MAKING AN APPROPRIATION; DECLARING AN EMERGENCY.

14	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
15	Section 1. TEMPORARY PROVISIONPUBLIC SCHOOL
16	TRANSPORTATION TASK FORCE CREATEDMEMBERSHIPDUTIES
17	TERMINATION
18	A. The joint interim "public school transportation
19	task force" is created. The task force shall function from the
20	date of its appointment until the first day of December prior
21	to the second session of the forty-ninth legislature.
22	B. The task force shall be composed of the
23	following members appointed by the New Mexico legislative

25	(1) four members from the house of

representatives;

- (2) four members from the senate; and
- (3) four other members, including a representative of a public school district, a charter school, a school bus contractor and an organization representing school bus transportation employees employed by school bus contractors.
- Mexico legislative council shall designate the chair and vice chair of the task force. Members shall be appointed from each house so as to give the two major political parties in each house the same proportionate representation on the task force as prevails in each house; provided that in no event shall either of the parties have less than one member from each house on the task force. Members may be removed from the task force by the New Mexico legislative council at the request of the chair of the task force for nonattendance according to council policy. Vacancies on the task force, however caused, may be filled by the New Mexico legislative council, or the council may reduce the size of the task force by not making replacement appointments and in such case need not adjust party representation.
 - D. After its appointment, the task force shall:
- (1) hold one organizational meeting to develop a work plan and budget for the approval of the New Mexico .175404.1

legislative council;

- (2) examine the statutes, constitutional provisions, rules and court decisions governing public school transportation in New Mexico, including those provisions related to the transportation funding formula; the personnel costs to school districts and school bus contractors; the costs of fuel, equipment and maintenance; and the administration of the public school transportation program; and
- (3) make a report of its findings and recommendations to the legislature and the governor on or before December 1, 2009. No action shall be taken by the task force if a majority of the total membership from either house on the task force rejects such action.
- E. Members of the task force are entitled to per diem and mileage as provided in the Per Diem and Mileage Act and shall receive no other compensation, perquisite or allowance.
- F. The staff for the task force shall be provided by the legislative council service in conjunction with the legislative education study committee, the legislative finance committee, the public education department and the office of education accountability of the department of finance and administration.
- Section 2. SUBCOMMITTEES.--Subcommittees shall be created only by majority vote of all members appointed to the task

force and with the prior approval of the New Mexico legislative council. A subcommittee shall be composed of at least one member from the senate and one member from the house of representatives, and at least one member from the minority party shall be a member of the subcommittee. All meetings and expenditures of a subcommittee shall be approved by the full task force in advance of such meeting or expenditure, and the approval shall be shown in the minutes of the task force.

Section 3. APPROPRIATION.--Twenty thousand dollars (\$20,000) is appropriated from the general fund to the legislative council service for expenditure in fiscal year 2010 to pay the expenses of the public school transportation task force. Any unexpended or unencumbered balance remaining at the end of fiscal year 2010 shall revert to the general fund.

Section 4. EMERGENCY.--It is necessary for the public peace, health and safety that this act take effect immediately.
