5 B. An owner of a pharmacy shall provide to a 6 consumer or the attorney general the current retail price for a prescription drug in any dosage or quantity when a consumer 7 or the attorney general requests that information by phone, 8 electronic device or otherwise. If a consumer requests the 9 10 current retail prices for more than five prescription drugs at one time, the owner shall provide the information to the 11 consumer no more than five days after the request is made; 12 provided that the consumer: 13

(1)requests the information in writing; (2) has a valid prescription for all the drugs for which the information is requested; and

has made no more than three separate 17 (3) requests to the owner for the current retail prices for more 18 than five prescription drugs within a six-month period. 19

20 C. Whenever an applicable law, rule or regulation requires or prohibits action by a pharmacy, responsibility 21 for the violation shall be that of the owner and the 22 pharmacist in charge. 23

As used in this section, "current retail price" 24 D. means the cash price for a prescription drug charged to a 25 SB 129
